- 1. Baptismal Certificate(s) for both Parties (if baptized) dated within the last six (6) months, with the Parish Seal embossed thereon and contain all relevant notations or a statement of "no notations".
- 2. Marriage Certificate dated within the last six (6) months with the Parish Seal embossed thereon.
- **3. Final Civil Divorce Decree** (a **certified copy** and NOT just a photocopy).
- **4. Required Fee Deposit:** a check in the amount of five hundred dollars (\$500.00) must be submitted with this questionnaire to secure the costs and expenses in this cause. If the case is not accepted for adjudication, the deposit will be refunded. If the Petitioner is financially unable to post this amount, the previous year's Income Tax Return should be submitted to support the claim and alternate arrangements will be made with the Petitioner by the Tribunal.
- **Required Opinion of the Parish Priest:** The Parish or other Priest who assists the Petitioner in the preparation of this questionnaire is requested to submit his written opinion of his interview with the Petitioner with special reference to the reasons for the failure of the marriage.
